BRIGHT FUTURE SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND DOES NOT INCREASE YOUR CHANCE OF WINNING.

SWEEPSTAKES DESCRIPTION: The Oklahoma 529 Bright Future Sweepstakes (the "Sweepstakes") consists of six (6) random monthly drawings which will be conducted on or around the first of each month beginning August 1, 2023 through January 2, 2024. One (1) monthly prize will be awarded to the winning Entrant, for the benefit of his or her child, grandchild or other loved one. The sweepstakes begins at 12:00 AM Central Time ("CT") on 7/1/2023 and runs through 11:59 PM CT 12/31/2023. Non-winning Entries will be automatically included in subsequent monthly drawings. Sweepstakes' details and Entry are available by clicking on the link posted on the home page of the Oklahoma 529 web site at www.oklahoma529.com.

SWEEPSTAKES SPONSOR AND ADMINISTRATOR: TIAA-CREF Tuition Financing, Inc. (TFI), Program Manager for Oklahoma 529 ("Sponsor").

ELIGIBILITY: Sweepstakes is open only to legal U.S. residents or taxpayers of Oklahoma - or current Oklahoma 529 account owners who are legal residents of the fifty (50) United States or District of Columbia ("DC"). Entrants must be at least eighteen (18) years of age or older at the time of Entry. Employees, directors, officers, trustees and agents, and their respective immediate families (spouses and siblings, parents and children and their spouses) and household members of TIAA-CREF Tuition Financing, Inc., TIAA-CREF Individual & Institutional Services, LLC, TIAA-CREF Personal Investors Services, Inc., Teachers Insurance and Annuity Association (TIAA) and its affiliates, their respective parent companies, affiliates, subsidiaries, owners, divisions, advertising and promotion agencies and employees of the Oklahoma Office of the State Treasurer and their immediate family members if the employee is directly involved with the management of Oklahoma 529 (collectively the "Sweepstakes Entities") are not eligible. All taxes and other costs associated with the Sweepstakes are solely the responsibility of the recipient.

AGREEMENT TO THE OFFICIAL RULES: By participating in the sweepstakes, the Entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor and Administrator, which are final and binding in all matters related to the Sweepstakes.

HOW TO ENTER: To receive one (1) sweepstakes Entry, visit www.oklahoma529.com, complete the Official Entry Form and submit online as directed. All Entries must be received by 11:59 PM CT on the last day of the month to be eligible for that month's drawing. **Limit: One (1) Entry per eligible Entrant.** In the event more than the stated number of allowable Entries are received for one person or email address, the first Entry processed will be considered the only valid Entry received. Any attempt by an Entrant to obtain more than the stated number of Entries by using multiple or different email addresses or identities will void that Entrant's Entries and that Entrant may be disqualified. In the event of a dispute, Entries will be deemed made by the authorized account holder of the email address submitted at the time of Entry. The authorized account holder is the natural person who is assigned to the email

address by an internet access provider, on-line service provider, or other organization that is responsible for assigning email addresses or the domain associated with the submitted email address. The potential sweepstakes prize winner may be required to show proof of being the authorized account holder. Use of any automated system to participate is prohibited and will result in disqualification.

WINNER SELECTION/VERIFICATION: Each monthly Oklahoma 529 Bright Future Prize winner will be randomly selected from among all eligible Entries and will be notified by e-mail to confirm their eligibility. Winners will be required to complete, execute and return within five (5) business days, an Affidavit of Eligibility and Publicity Release or the prize will be forfeited and awarded to an alternate. If selected prize winner does not meet the eligibility requirements, he/she will be disqualified, and an alternate winner will be randomly selected and notified as per the procedures outlined above. Random drawing will be conducted by Administrator. The odds of winning a prize depends on the number of eligible Entries received during the promotion.

PRIZES / APPROXIMATE RETAIL VALUE (ARV): Six (6) Sweepstakes Prizes - \$529 to be awarded in the form of a direct deposit into an Oklahoma 529 account. **BE SURE TO CAREFULLY REVIEW THE OKLAHOMA 529 PLAN DESCRIPTION AVAILABLE AT OKLAHOMA529.COM BEFORE ESTABLISHING AN OKLAHOMA529 ACCOUNT.**
